

A. Our aggressive growth plan targets all the major shale plays across the US over the next 3-5 years, including the Eagle Ford, Permian and Niobrara basins.




Q.What is your company's main strength or its edge over the competition? A. Fortis' experienced crews and equipment result

A. Lynden is a family of transportation and logistics companies built around a common goal: to develop mutually beneficial relationships with our client partners. We believe that complex transportation problems can be solved in the hands of the right people with the right tools and the right experience.

Q.Where is your company located? A.While most of the Lynden companies call Alaska and the Pacific Northwest home, the reach of our services and offices extends around the globe. Headquarters is located in Anchorage.

Q.What year was the company founded and by whom?

A. Lynden Transfer was founded in 1906 by Ed Austin in Lynden, WA. Henry Jansen and two partners purchased Lynden Transfer from Ed Austin's

widow in 1947. Lynden pioneered truck delivery to Alaska from the Lower 48 in the 1950s and is still considered the most knowledgeable and experienced in the Alaska market.

Q.What is the company's primary business sector?

A. The Lynden family of companies offers multi-modal transportation over land, sea and air, freight forwarding, logistics and 3PL services. Our array of transportation choices allow customers to only pay for the speed they need to meet their unique requirements. Lynden has built a reputation of superior service to diverse industries including oil and gas, mining, construction, retail and manufacturing.

Q.Where does your company do business?

A. Lynden provides transportation and logistics services to from and within Alaska, the contiguous United States and offshore locations such as Hawaii, Puerto Rico, Russia, Canada, Mexico and Papua New Guinea as well as locations around the globe.

All of our equipment is equipped to meet new emission standards and 90 percent is less than 5 years old. These newer more efficient tractors and ultra-efficient diesel engines have dramatically improved fuel economy and reduced air emissions.

Q. Is your company expanding any of its operations or locations?

A. In response to customer and industry demand in the Bakken Oil Field Reserve, Lynden added scheduled Less-than-Truckload (LTL) service to North Dakota and Oklahoma two years ago. Lynden Transport trucks depart twice weekly from Houston, Dallas, Oklahoma City and Tulsa bound for Williston, ND and points in Canada and Alaska. The service changes were made to give customers more choices with departures and arrivals in this very active market. Lynden has extensive experience moving equipment, supplies, and oversized freight in support of the oil industry in Texas, Alaska and Canada and is putting this expertise to use to support the development of the Bakken Oil Fields. Q. Is the company changing any of its services or products?

A.We have the largest number of frac fluids heating units in the industry and

> we are a licensee for the patented method of Heating On-The-Fly®. Just as other materials are added to frac fluids on the fly, we heat the fluids while they are being pumped from the water source to the frac fluid pumping equipment or the frac water

storage tanks located at the well site at the volumes and flow rates needed for well completion.

This process usually involves one or more of our units positioned in line between the water source and the frac water storage tanks located on the well site that is being frac'ed. The total volume per minute needed is pumped thru the units and heated to the customer's desired temperature, or a portion of the unheated fluids are taken out of the total flow to the frac tanks, called split-streaming, heated, and then returned to the flow line. Once heated, the fluids are either pumped directly to the pump trucks or transferred into holding tanks at the location prior to being pumped downhole by the frac service provider.

McAda Fluids Heating Services is an industry leader in using this methodology to heat frac fluids because of the size of our units. Smaller BTU rated units cannot provide the desired temperature rise in the flow line from the water source to the frac site.

Q. What is your company's main strength or its edge over the competition?

A. McAda Fluids Fluids Heating Service continually invests in additional frac fluids heating technology to ensure that our current inventory of equipment will meet the industry's need for high-volume,

on demand fluids heating services. We've built an inventory of modern, specially designed equipment, and have 16MM BTU, 21MM BTU, as well as 35MM BTU units.As a result of our inventory and HOTF license, we are equipped to handle any size job.

A.We have had a positive response from our customers in the Niobrara Shale when we moved into Colorado last winter.


