

As a contractor to oil producers, Native villages and regional corporations, Colville drives millions of miles annually across the paved, gravel, and ice road networks of the state to supply millions of gallons of fuel to our customers. We routinely provide ULSD, gasoline, AHF, Jet-A, and Avgas for North Slope operations, including the oil industry, marine and air carriers. We have an extensive and proven network of suppliers, highway transport tankers, bulk terminal tanks, and in-field delivery trucks. This comprehensive and proven system handles over 30 million gallons annually, and has the capacity to accommodate large volumes.

Our strategy integrates our clients' requirements within this

network, offering an efficient, broad-based supply and transport system that can handle an expansive range of requirements in both volume and type. We offer purchasing power economies of scale, a highly trained, specialized, and experienced workforce, and an established infrastructure in place. All of this is coupled with a company culture that engages safety and quality every day.

Additionally, Colville operates one of the largest public utility districts in the United States. Our Solid Waste service encompasses the Western region and the Dalton Highway region, including Kuparuk, Alpine, NPR-A west to the Ikpikpuk River, and down the Dalton Highway to Atigun Pass.

Q. Where is your company located?

A. Our Home office is in Prudhoe Bay, Alaska. Our transport facility and Ben's Towing are located in Fairbanks, and our administrative offices are in Anchorage. We also have NAPA stores in Kenai, Seward, and Soldotna.

Q. What year was the company founded and by whom?

A. Colville was founded in 1981 by legendary bush pilot, Bud Helmericks.

Q. What is your company's primary business activity?

A. The supply and delivery of fuel in Alaska is Colville's core competency.

Q. Are there important projects the company is currently a part of or has done recently?

A. Colville is an Arctic logistics and supply company so we are an integral part of our customers' projects. In 2018 we began barge fuel operations to accommodate the increased demand on the North Slope while reducing the congestion on the Dalton Highway. After completing a successful and safe first season, we —designed and fabricated equipment that will enable us to haul more fuel this season, with reduced risk of injury.

Q. How many employees does your company have?

A. While we have some seasonal fluctuation, there are approximately 200 employees year-round.

Q. Describe the equipment your company uses and are there any new equipment purchases planned?

A. We have a large delivery fleet of A and B train tractor trailers, fuel spreader trucks, portable fuel tanks, and solid waste bins. New

equipment purchases include fabrication of our 6th generation, Colville-designed portable fuel tanks and additional solid waste bins. This year we added our 6th generation of Colville-designed portable tanks, as well as additional equipment at our solid waste facility.

Q. Is your company expanding any of its operations or locations?

A. Historically, we have added bolt-on services in anticipation of our customers' needs, as well as upon request. A few recent examples include Brooks Commons Officeplex, a newly remodeled office and conference facility located adjacent to both Brooks Camp and Brooks Range Supply; propane sales and deliveries; steel sales, and expanded our heavy duty automotive division.


Q. What is your company's main strength or its edge over the competition?

Q. What do you most want people to know about your


company?

Doyon is an integral part of the Alaskan economy, providing economic benefits far beyond our shareholders.

Q. Where is your company located?

A. Doyon's corporate headquarters are based in Fairbanks, Alaska with administrative and subsidiary offices located in Anchorage and throughout the United States.

Q. What year was the company founded and brief history? A. Doyon was established on June 26, 1972 pursuant to the Alaska Native Claims Settlement Act (ANCSA) of 1971. Doyon is



one of 12 Regional land-based Alaska Native corporations. ANCSA was passed to resolve a longstanding land claims dispute between the Alaska Native people and the federal and state governments. Doyon is the largest private land holder in Alaska. The Doyon region encompasses 37 villages, 26 village corporations, the tallest mountain in North America, four military bases, and the longest rivers in the state.

#### Q. What is your company's primary business activity?

A. Doyon operates across three pillars: oil and gas, government contracting, tourism, and natural resources. In the oil and gas sector, our companies blend expertise and technological muscle in support of smooth, safe, and successful operations in the North Slope oil fields. In government contracting, we bring years of experience and an expert approach to our work with federal agencies. In tourism, we offer a variety of ways to experiences the splendor of the Denali National Park. In Natural resources, we manage the natural resources of our land with the utmost concern for safety and the environment.

Rig 26 is part of ConocoPhillips Alaska's long-term strategic plan to bring the capabilities of an extended reach drilling rig to the North Slope. DDI is the premier drilling contractor on the North Slope of Alaska and is a wholly-owned subsidiary of Doyon.



# Fluor awarded contract for Valvoline facility

Fluor Corp. announced Feb. 14 that it was awarded the engineering, procurement and construction management contract for Valvoline's new blending and packaging facility in Zhangjiagang, China. The project is Valvoline's first plant in China. Fluor booked the undisclosed contract value in the fourth quarter of 2018.

"With the growing automotive market in China, Fluor will assist Valvoline to meet the demand for its products by delivering this facility on schedule and with execution excellence," said Sandeep Nibber, president of Fluor's energy and chemicals business in Asia-Pacific. "Fluor is bringing several cost-competitive innovations, including minimizing onsite tank farm fabrication work, to perform this schedule-driven project."

The 80,000-square-meter plant will have the capacity to produce more than 30 million gallons of finished lubricants and coolants annually for passenger cars and heavy duty vehicles. More than 600 workers are expected onsite at peak during construction. Production at the plant is expected to begin by the end of 2020.

# Nabors appoints Anthony Chase as a director

Nabors Industries Ltd. announced Feb. 25 that it has expanded its board to seven members and appointed Anthony R. "Tony" Chase to fill the vacancy. Chase is the chairman and chief executive officer of ChaseSource L.P., a Houston-based staffing and real estate development firm. # Fluor awarded Halliburton project in Saudi Arabia

Fluor Corp. announced Feb. 20 that it was awarded the engineering, procurement and construction of the Halliburton specialty chemicals manufacturing reaction plant located in the PlasChem Park, Jubail, Saudi Arabia. Fluor booked the undisclosed contract value in the fourth quarter of 2018.

"Having completed the front-end engineering design, we are pleased to undertake the design and construction of this major investment that accelerates Halliburton's strategic expansion of its fast-growing specialty chemicals business,"



said Simon Nottingham, president of Fluor's energy and chemicals business in Europe, Africa and the Middle East. "Fluor will use its full integrated solutions portfolio and its local execution capabilities to optimize the design and deliver a capital-efficient project with schedule certainty."

The new chemicals facility will produce a wide range of specialty chemical products and intermediates to supply both the upstream and downstream oil and gas production industries. Fluor's scope includes engineering, procurement, construction and commissioning.

Fluor's Al Khobar office in Saudi Arabia will lead the project with the team that performed the previous front-end engineering design contract and will be supported by Fluor's global chemicals experts.

# Fluor awarded contract for recommissioning project

Fluor Corp. announced Feb. 26 that it was awarded an engineering, procurement and construction management services contract by SABIC for the recommissioning of its polyphenylene ether resin plant in Bergen op Zoom, the Netherlands. Fluor will book the undisclosed contract value in the first quarter of 2019.

"We are pleased to support SABIC with this important recommissioning project at the Bergen op Zoom site where Fluor has more than 30 years of experience of providing innovative solutions to the client," said Simon Nottingham, president of Fluor's Energy & Chemicals business in Europe, Africa and the Middle East. "Fluor's proven track record in brownfield projects and construction-driven execution will minimize disruption at this complex operations site and provide cost and schedule certainty."

SABIC announced the project last year, in response to high global customer demand for its unique NORYLTM resins, based on PPE resin technology. NORYL resins are SABIC's proprietary family of modified compounds. Recommissioning the Bergen

op Zoom PPE resin facility will provide customers with a second source of NORYL resins globally and affirms SABIC's commitment to the European market and global customers who specify their NORYL resin material needs from Europe. When operational, the Bergen op Zoom facility is expected to add more than 40 percent global capacity over a 2017 baseline.

The 14-month project began in January 2019 led by Fluor's Bergen op Zoom office and will be supported by Fluor's Cebu office in the Philippines.

### **Keel laid for new** Foss Maritime tier IV vessel

Foss Maritime said Feb. 27 that it is continuing its ongoing fleet expansion program with the keel laying of the first of its new class of ASD 90 tugboats. Construction of the first of four Tier IV ASD 90 Tractor Tugs being built for Foss Maritime began with a keel laying at Nichols Brothers Boat Builders of Freeland, Washington.

In a ceremony on Feb. 25 the vessel keel was laid and welded before NBBB, Foss and other representatives and guests. The keel laying also marks the implementation of a new production line at NBBB, which will improve efficiencies to



meet the accelerated four-boat order.

The ceremony began with NBBB welding a silver dollar into the keel, an old nautical tradition. This was followed by comments by representatives of both NBBB and Foss.

"The new tugs are designed to upgrade our fleet and improve the company's ability to provide timely harbor and port services to a variety of customers," said John Parrott, president and CEO of Foss Maritime. "By offering lower maintenance down time, greater operating efficiencies and lower emissions, these new tugs help expand our nearshore and offshore capabilities."

Foss has an order for four of the new class of ASD 90 tugs, with an option for an additional six. Designed by Jensen Maritime Consultants of Seattle, and based on Jensen's Valor tugboat design, the vessels will meet Tier IV standards, using high-efficiency catalytic after-treatment technology to reduce emissions.

Foss plans to operate the tugs on the U.S. West Coast, performing ship-handling duties within ports and harbors. Delivery of the first four vessels will begin in winter 2020.

### Four board members elected at Doyon annual meeting

Doyon Ltd. said March 15 that at its annual meeting of shareholders four individuals were elected to Doyon's 13-member board of directors. Elected with three-year terms ending in 2022 were Betty Huntington, Jerry Isaac, Sonta Hamilton-Roach and Miranda Wright.

Notti spoke of the history of the Alaska Native Claims Settlement Act, the strength and stamina of Alaska Native people, the work that still needs to be completed, and the future of Doyon and its shareholders. Notti was the first president of the Alaska Federation of Natives and was a force behind the land claims movement and negotiations that culminated in the ANCSA.

Shareholder of the year award recipients are Doyon Citizen of the Year, Roy Nictune of Alatna and Bettles, Richard Frank Military Service awardee, Tanna Carter of Minto, and Chief Andrew Isaac Leadership awardee, Sheree Titus of Northway.

### Fluor joint venture completes work on Sasol project

Fluor Corp. announced March 19 that its joint venture with TechnipFMC has successfully completed its engineering, procurement and construction management services scope of work on Sasol's world-scale petrochemical complex in Westlake, Louisiana. The joint venture will continue to provide assistance to the Sasol team with remaining activities by working

with Sasol in parallel on transition plans for each unit and system. The joint venture team will also assist in performance testing for the complex.

A 1.5 million-ton-peryear ethane cracker is at the heart of the complex, which also in-



cludes six downstream chemical units and associated utilities, infrastructure and off-sites. All units have been transitioned to Sasol except for the low-density polyethylene unit, which will be handed over by the end of March 2019.

"This milestone is the culmination of nearly seven years of hard work by Fluor's project team and we are proud to have successfully delivered our scope," said Mark Fields, president of Fluor's energy and chemicals business in the Americas. "We brought our extensive U.S. Gulf Coast construction and megaproject expertise using our integrated solutions approach, and we are proud of the lasting positive impact this project will have on Southwest Louisiana."

More than 6,000 staff and craft were on site at peak to build the complex. The Fluor joint venture integrated a team of 30 main construction contractors and worked in collaboration with Sasol to strengthen the local economy, with more than \$4 billion committed to Louisiana businesses, and contributing more than \$185,000 to local schools and charitable organizations throughout the project.
